Final Report

IMPRESSION: 1. Lumbar spine BMD WHO classification is now classified as osteoporosis, T-score -2.5, previously -2.1. There has been a statistically significant reduction of quantitative bone mineral density assessment of 6.6%, compared to baseline study of 06/23/2010.
2. Femoral neck BMD WHO classification is again at the low normal range, no significant quantitative bone mineral density change.
3. Total hip BMD WHO classification is again at the low normal range, T-score -1.0, with no significant change in quantitative bone mineral density since the study of 06/23/2010.
