HISTORY:

Osteoporosis

EXAM: DEXA bone densitometry.

COMPARISON: May 6, 2015

FINDINGS: Evaluation of the AP lumbar spine from L1 through L4 reveals a T-score of -3.5. Evaluation of the femoral neck mineral density of the left hip reveals a T-score of -2.1. Evaluation of the left hip reveals a T-score of -2.0.

There has been and a percent increase in bone density in the lumbar spine and no significant interval change in bone density in the left hip when compared to the previous exam.

WHO Criteria:

- Normal: T-score at or above -1.0
- Osteopenia: T-score between -1.0 and -2.5
- Osteoporosis: T-score at or below -2.5

IMPRESSION:

Findings consistent with osteoporosis in the lumbar spine and osteopenia in the left hip and left femoral neck.

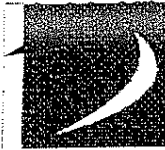
